WALK-IN-INTERVIEW FOR GDMOs & SPECIALIST DOCTORS FOR SSB

Sashastra Seema Bal (SSB) proposes to engage 74 (seventy four) General Duty Medical Officers (GDMOs) and 17 (seventeen) Specialists for their various locations/formations throughout the country (purely on contract basis) as per terms and conditions mentioned below:-

The terms and conditions for the said posts are given as under:-

1. **Remuneration** The following consolidated remuneration per month will be admissible.

(i)	For Specialists	-	Rs.85,000/- p.m.
(ii)	For GDMOs	-	Rs.75,000/- p.m.

The contractual appointee will not be entitled to any other allowances, benefits or concessions as admissible to Govt. employees.

2. **Age.** All doctors appointed will not continue on the post once he/she reaches 67 years of age.

3. The initial contractual appointment will be for a period of three years which may be extended for further 2 years on year to year basis subject to the maximum age cap of 67 years or till regular incumbent joins whichever is earlier. The services of the appointee are also terminable before expiry of the contractual period by either side after giving one month notice or salary in lieu thereof. The selection is purely contractual in nature and does not carry any right for regularization or permanent absorption.

4. **Leave.** The leave entitlement of the appointee shall be governed as per DoP&T O.M. No.12016/3/84-Estt(L) dated 12th April 1985, as amended from time to time.

5. No TA/DA is admissible for the interview. Suitable and willing candidates may **WALK IN FOR INTERVIEW** at scheduled places along with original and photocopies of all relevant documents (like Graduate Degree, internship completion certificate, age proof and experience certificate if any etc) and application in plain paper superscripting the name of post applied for in the State/area/region and five passport size recent photographs. The Directorate General of SSB will finally decide the place of posting state/area/region etc with the approval of the competent authority.

6. The competent authority reserves the right for any amendment, cancellation and change in this advertisement in whole or part thereof without assigning any reason.

7. **Educational/professional qualifications for the posts are as under :-**

Specialists

(a) A recognized medical qualification included in the first or Second Schedule or Part II of the third Schedule (other than that licentiate qualifications) to the Indian Medical Council Act, 1956. Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions stipulated in sub-section(3) of section (13) of the Indian Medical Council Act, 1956.

(b) Post-Graduate Degree/Diploma in the concerned Specialty as mentioned in Section-A or Section-B of Schedule-VI or equivalent.

Experience. 1 ½ years experience for Post Graduate degree holder & 2 ½ years for Diploma holder in the concerned specialty after obtaining the Post Graduate Degree/Diploma or equivalent.

GDMOs

(a) A recognized medical qualification included in the first or Second Schedule or Part II of the third Schedule (other than that licentiate qualifications) to the Indian Medical Council Act, 1956. Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions stipulated in sub-section(3) of section (13) of the Indian Medical Council Act, 1956.

(b) Completion of compulsory rotating internship.

8. **Medical Examination.** Immediately after interview on the same day candidates will be medically examined by a Board of Medical Officers detailed by concerned Composite Hospital. Appointment will be subject to Physical fitness.
