However, the company shall not be responsible for any application being rejected or candidate not shortlisted due to incorrect data.
- 5. Candidates who have passed Apprenticeship under Centre of Excellence (COE) scheme need not apply.
- 6. Web portal www.apprenticeship.gov.in is being operated by DGET, Government of India. For enquiries regarding the issues related with web portal, the candidates are requested to contact help line numbers mentioned in the web portal. Correspondence with respect to functionality of portal will not be entertained by HAL.
- 7. Merit list of the selected candidates will be hosted online in the website of the company www.hal-india.com. Candidates are requested to visit the website for the same.
- 8. No TA/DA will be paid for attending document verification process. Candidates will have to make their own arrangement for stay, if required, during verification process.
