Whereas, posts of "FMPHW" of Govt. Medical College Jammu & its Associated Hospitals were referred to JKSSB, the Board advertised these posts vide advertisement No. 05 of 2015 (Item No. 267);


Whereas, the select list for the above mentioned posts of "FMPHW" was finalized and issued by JKSSB vide Letter No: SSB/Secy/Sel/2016/14070-76 dated: 19-05-2016 which was endorsed to this office by the Administrative Department i.e. H&ME vide letter No. ME/NG/115/2016 dated: 27-06-2016;

Whereas, this office had issued an order of appointment vide order no. 166/AHJ/2016 dated: 12.07.2016 in favour of 16 candidates whose cases were cleared in the above mentioned selection list issued by the JKSSB;

Whereas, in pursuance of Hon'ble High Court's interim directions passed in SWP No. 2512/2015, titled Abhishek Sharma & Others Vs. State of J&k and Ors. and in reference to the Secretary, JKSSB's letter No. SSB/A-51/15/1455-57/16 dated: 14-06-2016 the above mentioned appointment order issued in favour of 16 candidates was kept in abeyance with immediate effect vide this office order no. 178/AHJ of 2016 dated: 16.07.2016, and further order no. 166/AHJ/2016 dated: 12.07.2016 was cancelled ab-initio vide order no. 57-AHJ of 2018 dated: 17.05.2018.

Whereas, the Hon'ble High Court in SWP No. 2512/2015, MP Nos. 5/2017, 3/2016, 1/2015, 4/2017, 3/2017 titled Abhishek Sharma & Ors. Vs. State & Ors. c/w SWP No. 2532/2016, MP Nos. 5/2017, 4/2017, 7/2017, 9/2017 and SWP No. 3131/2015, MP No. 1/2015 titled Nancy Kumari Bhat & Ors. Vs. State & Ors. and Naresh Kumari & Ors Vs. State & Ors. and passed orders on 04-05-2018 which reproduced as: "...The official respondents would be free to appoint the candidates selected pursuant to advertisement notice Dated 01-09-2015 pursuant to the select list under reference....";





Whereas, after perusing the select list issued by JKSSB, it was observed that the recommendation in the cases of 35 numbers of candidates was withheld for want of fulfilment of certain deficiencies. However, the recommendation withheld were released later on by the JKSSB vide their above mentioned references.

Now, therefore, in compliance to order dated: 04-05-2018 of Hon'ble High Court, sanction is hereby accorded to the appointment of following candidates as "FMPHW" in Govt. Medical College Jammu & its Associated Hospitals (Division Cadre Jammu) in the pay scale of 5200-20200+1900.




The appointment of the candidates shall subject to fulfilment of the following conditions:-

- A. The appointment including pay, service etc. shall be governed as per the provisions of SRO-202 dated 30-06-2015 (J&K Special Recruitment Rules, 2015).
- B. The appointee shall report to the Principal, Govt. Medical College, Jammu within a period of 21 days from the date of issuance of this Order.
- C. In case, the appointee fails to join the department within the stipulated period of time, his/her appointment shall be deemed to have been cancelled without any further notice.
- D. The appointee shall be allowed to join only on the production of the following documents/certificates in original:-
 - a. Academic/ Technical Qualification Certificate.
 - b. Matriculation/ Date of birth Certificate.
 - c. Health Certificate from the concerned Chief Medical Officer of the District.
 - d. Permanent Resident Certificate issued by the competent Authority.
 - e. Certificate from the concerned District Industries Centre (DIC) and the District Employment and Counselling Centre to the effect that no loan under self employment scheme has been taken by the appointee.
 - f. Relevant Category Certificate (if any).
 - g. Character Certificate from the concerned Police Station.
- E. The appointment of the candidate as FMPHW shall further be subject to the following conditions:-
 - i. The appointee shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about his/her character and Antecedents is received from the Inspector General of Police, (CID) J&K to whom a reference shall be made by the concerned, the candidate shall have no right to claim his/her appointment as FMPHW and his/her appointment as such shall be deemed to have been cancelled ab-initio.
 - ii. If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled ab-initio.
- F. The salary of the appointees shall be disbursed only on receipt of the satisfactory report with regards to character and antecedents and verification in respect of documents and testimonials i.e. Academics, Technical and Category (if any) from the verifying agency.
- G. The appointment of the said candidate shall be governed by "New Pension Scheme" as per SRO-400 of 2009 dated: 24-12-2009.

- H. The inter-se-seniority of the appointee shall be in order of merit furnished by the J&K Service Selection Board which shall be notified separately.
- I. The appointment in Divisional Cadre is not transferable from one Division to another and change of Cadre is not acceptable.

The appointment of the selected candidates is subject to the outcome of any writ petition(s) if any pending in any Hon'ble Court(s) of Law.
