The Medical Superintendent, Dr. Ram Manohar Lohia Hospital, New Delhi invites applications from Indian National in the Prescribed form (**Annexure-I**) for the post of **Junior Residents (Non Academic) on regular basis**. The reservation of posts will be as per 200 Point Roster.

- Vacancy may increase or decrease at the time of selection. The Number of Vacant post indicated as above are provisional and 4% or 09 seats are reserved for PwD (Ortho) Candidates includes anticipated vacancies. This is subjected to change without any notice.

2. Emoluments: -

Pay scale Rs. 56100-1,77,500/- plus applicable admissible allowances in pay matrix (level 10) under CCS (Revised Pay) Rules, 2016 at entry level.

3. Eligibility:-

- a) MBBS from a recognized University.
- b) Should be registered with Delhi Medical Council (DMC). Provisional Registration Certificate and receipt will not be considered.
- c) Only those candidates who have completed / likely to complete Internship by **15.05.18** may apply.
- d) The candidates who completed Internship before **15.05.16** need not apply; as such candidates would not be eligible.
- e) Those who have already done/doing six months/more than six months Jr. Residency in Government organization are not eligible.

4. Age Limit:

- a) Not exceeding 30 years for UR (relaxable by 5 years for SC/ST, 3 years for OBC) as on **12.06.2018**.
- b) Age Relaxation of 10 years for Persons with Disability (15 years for SC/ST and 13 years for OBC candidates).

5. Reservation:

All reservations will be considered in the above posts strictly in accordance with prescribed norms/rules.

- a) SC/ST candidates to submit copy of community/caste certificate from desirable authority.
- b) OBC candidates should submit OBC Certificate as per given **Annexure-II having date of issue on or after 01.04.2016 vide OM No. 36036/2/2013-Estt.(Res-I) dated 31.03.2016 of DOPT, Ministry of Personal & Public Grievance & Pensions, New Delhi.**
- c) Persons with disability (PWD) to produce/submit a certificate issued by a competent medical authority.
