Whereas, Health & Medical Education Department referred 01 post under Open Merit vide letter No. ME/Gaz-187/2014 dated 11.04.2017, 05 posts [OM:03, RBA:01 & ST:01] vide letter No. ME/Gaz-187/2014 dated 11.04.2017 and 08 posts of Lecturer [OM:07 and RBA:01] vide letter Nos. ME/Gaz-187/2014-I dated 11.04.2017 and No. ME/Gaz-154/2012 dated 15.06.2017 in the discipline of Obst. & Gynae (GMC-Jammu/Srinagar) for recommendation of selection of suitable candidates; and

Whereas, J&K Public Service Commission advertised these posts vide Notification No. 02-PSC (DR-P) of 2017 dated 01.05.2017 and No.05-PSC (DR-P) of 2017 dated 10.07.2017; and

Whereas, 30 and 43 applications were received vide Notification No. 02-PSC (DR-P) OF 2017 dated 01.05.2017 for GMC, Srinagar and Jammu respectively and 41 applications received for GMC, Srinagar vide Notification No. 05-PSC (DR-P) OF 2017 dated 10.07.2017. Out of these, 29 candidates and 39 candidates under first notification and 38 applicants under second notification were found eligible and called for interview; and

Whereas, the interviews of the candidates were conducted w.e.f. 14.05.2018 to 16.05.2018 with the assistance of experts from outside the State; and

Whereas, 01 more candidate was allowed to participate in the interview on the directions of the Hon'ble High Court in SWP No.1549/2017, MP No.1/2017 dated 09.08.2017 titled Dr. Shaheena Vs State & Others. The operative part of the directions are reproduced as under:-

*"In the meantime, respondents are directed to allow the petitioner to participate in the process of selection and the result thereof shall not be declared until further orders from this court."*

Whereas, one post under RBA Category and one post under ST category against Notification No.02-PSC (DR-P) of 2017 for GMC, Jammu left vacant due to non-availability of candidates.

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980 as amended from time to time and other related parameters, the list of the candidates who have appeared in the interview is enclosed as Annexure-"A" to this Notification.

Consequent upon the above, the **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.

1. The Commission reserves the right to have certificates/documents of the candidates verified, if it is at any stage found expedient to do so. The Select List is purely provisional and is subject to the outcome of writ petitions pending before any competent Court of law.


