**RESULT OF THE RECRUITMENT FOR THE POST OF THE
JUNIOR CLERK-CUM-COPYIST, JUNIOR TYPIST AND
STENOGRAPHER GRADE III**

In pursuance to the Advertisement published in the odia daily news paper "The Samaj" and "The Dharitri" dated 24.09.2017 of office of the District and Sessions Judge, Angul, the following select-cum merit list of the successful candidates in order of Merit are drawn up for filling up the post of Junior Clerk-cum- Copyist, Junior Typist and Stenographer Grade III of this Judgeship. Further, in respect of appointment for the post of Junior Clerk-cum-Copyist is subject to the result of the Writ Petition in WP (C) No. 22278 of 2017 (Soumerendra Debata and Others Vs. Govt. of Odisha and Others).

No right is conferred upon the candidates to claim appointment as matter of right if they are found not suitable by the Appointing Authority.

The Merit list of the successful candidates shall remain valid for a period of One Year from the date of 1st appointment from such list or till the date of notify for next Recruitment Examination, whichever is earlier sub-Rule 6 of Rule 7 of Orissa District Subordinate Courts Non-Judicial Staff Services (Method of Recruitment and condition of Services) Rules 2008 and amended Rule 2010.
