Declaration of Result

Himachal Pradesh Department of Transport, Shimla-4 declared the result for the recruitment of Class-IV Category i.e. **08** post of **Peon on daily wage**, **03** post of **Chowkidar on daily wage** and **02** post of **Part Time worker** in Transport Department which were advertised by the department vide Employment Notice dated 08th March 2017.

On the basis of Academic Qualification documents verification conducted by the department w.e.f 17.04.2017 to 13.06.2017, the Department of Transport had prepared the result of 08 posts of Peons on daily wage basis, 03 posts of Chowkidars on daily wage basis and 02 post of Part Time Worker and kept in the sealed cover due to implementation of Modal code of Conduct in the State. Now the Government vide letter dated TPT-B(1)-3/2009-I dated 06.04.2018 has accorded the approval to declare the result of these posts. Accordingly sealed covers were opened in the department on 02.05.2018 and the candidates bearing following serial numbers/ particulars have been declared successful.
