The outsourcing agency is responsible for payment of remuneration to each candidate after receiving the consolidated amount from this office. As far as E.P.F. is concerned, the employees contribution would be deducted from his/her remuneration, as far as employers contribution is concerned, the outsourcing agency will have to pay and there will be no reimbursement of this amount separately to the agency. The payment of service tax is also the responsibility of the agency. The other things as indicated in the G.O. and guidelines will apply in the areas of service conditions of employees and employer.

The outsourcing agency is informed that if any particulars are found wrong in due course, the appointments shall stand cancelled and further action will be taken against the concerned as per Rules.

The outsourcing agency is informed that if any term in the guidelines is not followed, necessary action will be taken against the agency in terms of the rules in vogue.
