**Selection Criteria:**

Memo No. HWF/NRHM-20/206/(Part-11)1631 Dated 27.06.2012 of Govt. West Bengal, Health & Family Welfare Deptt. (NRHM).

**Eligibility:**

1. Should be Married women/Divorced or Widowed women.
2. Should be a resident of the same village for which she will be selected.
3. Should be within the age group of 30-40. In case of SC and ST candidates, the lower age limit may be relaxed to 22 years (cut of date of age as on 01.01.2018).
4. Should be Madhyamik appeared or equivalent.
5. Women candidate who are Madhyamik pass or possessing higher qualification, only marks obtained in Madhyamik or equivalent examination will be considered.

**Mode of Application:**

1. Candidates should submit application in the format and annexed as Annexure "B" to this notification.
2. Application should be in A4 size white paper on one side only and should be clearly legible.
3. Application Form can be downloaded from the website [uttardinajpur.nic.in](http://uttardinajpur.nic.in)
4. One candidate is allowed to submit only one application, more than one application if submitted by the same candidate; remaining application/s will not be entertained.
5. Candidate may collect information and assistance in filling of the Application Form from their respective Health Sub Centres / GP Office / BPHC.

**Documents to be submitted with the application (Xerox copy with self attestation):**

1. Copy of proof of residence (Voters Identity Card / Ration Card)
2. Copy of Mark sheet of Madhyamik or equivalent examination as applicable, Mark sheet is to be provided by the candidates even in case of failure in the exam,
3. Copy of SC/ST Certificate.
4. Copy of experience certificate, in case of Grade-I & Grade-II SHG members/trained Dais/Link workers.
5. One self addressed envelope with postage stamp of Rs. 5/-.



**Selection Process:**

1. Selection is based on marks obtained by the candidates in the Madhyamik/ equivalent examination (90% weightage).
2. Score in the interview (10% weightage)
3. Areas where the majority of the population belongs to the ST/SC, preference to be given to women from that category keeping the selection criteria fixed.
4. Preference to be given to Grade-I & Grade-II SHG members/trained Dais/ Link Workers keeping the selection criteria fixed.

**Whom to Apply:**

1. The application may be sent by speed / registered post with AD so as to reach the below mentioned address on or before closing date and time.
2. Candidate can also submit the application in the DROP BOX kept for the purpose at the respective B.D.O. Office on or before the closing date & time.
