Assistant Security Officer (Stage-I)

On the basis of the Computer Based Test (CBT) (Stage I) held on 03^{rd} September, 2017, the following is the Roll Number wise list of **Candidates** who have **Provisionally Qualified** for the Physical Standard Test Examination (**Stage-II**) for recruitment to the post of **Assistant Security Officer** at AIIMS, New Delhi. The Examination was conducted with reference to Vacancy Notice published in the Employment News dated 28^{th} August -3^{rd} September, 2010 & 30^{th} November -6^{th} December 2013, Corrigendum and Scheme of Examination uploaded on the website on 21^{st} August, 2017.

As per Scheme of Examination, the qualifying criteria for **Stage-I** (Online (CBT) Mode Examination) and eligibility for the Physical Standard Test (PST) [**Stage-II**] was as follows:

- **a.** The candidate will have to score a minimum of 50% for UR and 40% for SC categories to qualify in the theory Examination (**Stage-I**) to be eligible for the Physical Standard Test (PST) [**Stage-II**].
- **b.** Only those candidates who will qualify in **Stage-I** will only be called for **Stage-II** test.

Accordingly, on the basis of criteria mentioned in the Scheme of Examination **22 candidates** have qualified in Online (CBT) Examination and are eligible to be called for the Physical Standard Test (PST) [Stage-II].



No other screening has been performed at this stage with regard to their eligibility and any other relaxation. These will only be determined at time of verification of their Original documents by the Recruitment Cell, AIIMS, New Delhi after declaration of **Final Result**. These results and eligibility are provisional subject to fulfillment of all requirements mentioned in the advertisement and Scheme of Examination. Being eligible at any of the stages is therefore subject to verification of all relevant documents at the time of verification of documents after declaration of Final Result.
