Stenographer Grade III in Services Department under Postcode 211/2014

- 1. The DSSSB vide its advertisement No. 02/2014 with closing date 25.01.2015, had advertised 47 vacancies (42 UR, 03 OBC, 01 SC, 01 ST including 01 HH, 05 EXSM, 02 SP) for the post of Stenographer Grade III in Services Department under Post code 211/2014 which were further increased to 349 vacancies (173 UR, 100 OBC, 36 SC, 40 ST including 07 VH, 01 HH, 04 OH, 42 EXSM, 02 SP) vide addendum dated 07.06.2018. Board conducted Tier-I written examination for selection to the post along with similar postcodes on 11.06.2017. Board had declared marks of Tier-I written examination of the candidates of the post of Stenographer Grade III in Services Department under Post code 211/2014 vide notice number 550 dated 06.10.2017.
- 2. Based on the performance in the one tier examination, 489 candidates were shortlisted for appearing in Shorthand and Typewriting Skill Test vide notice number 564 dated 25.10.2017. The skill test result for shorthand and typewriting was conducted w.e.f. 08.02.2018 to 11.02.2018, wherein 337 candidates have appeared. The result status of these candidates are being uploaded in OARS module, concerned candidates can check their status by logging into their account in OARs module on www.dsssb online.nic.in.
- 3. The Board has adopted the criteria for evaluation of the skill test and in the skill test considered upto 7% mistakes for UR category and upto 10 % mistakes for all reserved category candidates, on the pattern of SSC, as qualified in the shorthand skill test with a speed of 80 w.p.m.
- 4. As per RRs for the post the candidate was to qualify the 40 w.p.m. in typewriting in English or 35 w.p.m. in typewriting in Hindi.
- 5. On basis of above parameters out of 337 candidates who appeared for Shorthand skill test and Typewriting skill test, only 164 candidates have qualified the both Shorthand skill test and Typewriting skill test.

6. Based on the qualifying both Shorthand skill test and Typewriting skill test following 164 candidates having roll numbers are provisionally allowed to upload e-dossiers subject to correctness of the information furnished by the candidates in their online application forms.

- 10. The e-dossier link shall be active from 26.7.2018 to 9.8.2018.
- 11. As Board has conducted the combined examination for the post of Junior Stenographer (English) in NDMC under postcode 47/12; for the post of Stenographer (Grade III) in MAIDS under postcode 152/14 and for the post of Stenographer (Grade III) in Services Department under postcode 211/14, the common candidate may give their preference of posts in the e-dossier.
- 12. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
- 13. In case of non-compliance of the above instructions regarding uploading the e-dossier, the candidature of the candidate is liable to be cancelled /rejected.
