Public Service Commission, West Bengal will conduct the Typing Test on Computer as a part of Stenographer, 2016 Examination, on Saturday, the 6<sup>th</sup> October, 2018 in two batches at 10:30 a.m. (bearing Roll No. 3179291439 to 3281164704) and at 12:30 p.m. ( bearing Roll No. 3281164764 to 3288008389 ) at "PAREEKSHA" Online Examination Centre, UPTC-BF-01, Upohar Town Centre, New Garia, Kolkata-700094. The Admit Card will be available in the respective personal e-mail id as provided by the candidates on and from 1<sup>st</sup> October, 2018. The candidates are advised to take a print out of the Admit Card from their personal e-mail id.

Those candidates who will not receive the above mentioned e-mail for the purpose of downloading Admit Card upto 3<sup>rd</sup> October, 2018, are advised to go through the list of successful candidates already uploaded in Commission's website ( <http://www.pscwbonline.gov.in> ) and are also advised to contact personally .

The admitted candidates shall have to produce the printout of their Admit Cards at the allotted venue for appearing at the specified examination. Candidates are directed to carry two identical **passport size photographs** along with photo identity proof bearing photograph and signature viz. PAN Card / Passport etc. **No paper Admit Card will be issued for this examination by the Commission and no such card will be sent to the candidates by post or will be available from the Commission's office / website.**

In case of any discrepancy in the Admit Card the same may be communicated to the Commission immediately to enable the Commission to take a decision in the matter.

Candidates are also advised to bring **Black Ball Point Pen** to the examination hall.

**CANDIDATES ARE ADVISED NOT TO BRING ANY ITEM EXCEPT THOSE REQUIRED FOR THE PURPOSE OF EXAMINATION, e.g. ADMIT CARD, ID PROOF ETC.**
