  - 5- Hon'ble the Supreme Court vide order dated 30.07.2018 passed in Writ Petition(s) (Civil) No(s) 519/2018 has made clear that
    - "In all other cases, in which examinations have been conducted, the High Courts are permitted to publish/declare the result of the writ petitions.
    - Subject to the further orders, the candidates who passed the examination shall be permitted to participate in the subsequent rounds of selection.
    - However, it shall be made clear at every stage that their participation is subject to the result of the writ petitions."
