The Haryana Public Service Commission has finalized the result for recommendation of the candidates for the posts of Veterinary Surgeon in Animal Husbandry & Dairying Department, Haryana against Advertisement No. 2(viii)/2014 published on 28.04.2014, 6(2)/2015 published on 17.11.2015, Corrigendum dated 10.08.2016 & corrigendum dated 23.08.2016 and Advertisement no. 1(1)/2017 published on 02.05.2017 published in various newspapers. Note:

1. While preparing the result due care has been taken. However, any inadvertent error cannot be ruled out. The Commission reserves its right to rectify any error at a later stage.
2. As per clarification given by the Animal Husbandry & Dairying Department, Haryana vide its letter no. 3182-P.PA.-3-2017 / 15041 dated 04.12.2017, if sufficient number of candidates are not found in BC/ESM category and posts remained unfilled, then 04 posts will be filled up from the candidates belonging to Dependent of Freedom Fighters (DFF) of Haryana category. Against 15 posts reserved for ESM of Haryana category candidates, only 10 DESM and 1 DFF candidates are available. Accordingly, all these available 11 candidates are being recommended against the posts reserved for ESM category.

For three posts out of the remaining unfilled 4 posts of ESM category, the candidature of the candidates belonging to DFF category, who were not declared qualified earlier in any of the categories in the result dated 27.07.2018, is under consideration of the Commission. If anyone is found eligible & suitable, his name will be recommended later on against these posts. However, the selection of all the candidates of DFF category will be subject to the final outcome of the writ petitions filed by the DESM category candidates (23448/2018, 23620/2018 & 24976 of 2018).

The above result is subject to the final outcome of CWP Nos. , 20959 of 2017, 13999 of 2018, 19015 of 2018, 19388 of 2018, 19778 of 2018, 19977 of 2018, 20776 of 2018, 20877 of 2018, 21158 of 2018, 21170 of 2018, 22028 of 2018, 23380 of 2018, 23448 of 2018, 23526 of 2018, 23620 of 2018, 23774 of 2018, 24431 of 2018, 24976 of 2018 & COCP 436 of 2018, CM No. 13803 – CWP-2018 in CWP No. 22028 of 2018, pending before the Hon'ble Punjab & Haryana High Court.
