6. Aadhaar Card in original and it's photocopy duly attested by the candidate.
7. Caste Certificate by Birth in support of claim as SC/ST, wherever applicable (Caste Certificate by virtue of marriage is not accepted).

8. Candidates of SEBC category (other than Creamy Layer) must have to submit Caste Certificate by birth issued by the Competent Authority (issued within 3 years), wherever applicable (Caste Certificate by virtue of marriage is not accepted). OBC Certificate will not be accepted in lieu of SEBC Certificate.
9. In case of Sports Person candidates: Identity card issued by Director of Sports, Odisha.
10. In case of PWD candidates: Disability Certificate (Indicating % of disability) issued by concerned Medical Board, wherever applicable.
11. In case of Ex-Servicemen candidates : Discharge Certificate issued by the Commanding Officer of the Unit Last served/Identity Card issued by Rajya Sainik Board or Zilla Sainik Board in original.
