#### **Post-1:**

**B.E. / B.Tech engineering graduate in the disciplines of Electronics / Mechanical/ Electronics & Instrumentation/ Electrical & Electronics and Computer Science. Relevant post qualification hands-on industrial experience will be an added advantage.**

#### **Post No.2:**

**3-year full time Diploma in any discipline with at least 60% aggregate marks from any institution recognized by the State Board of Technical Education. Post qualification relevant industrial experience will be an added advantage.**

**Post No.3: Should have passed ITI (2 years duration) in the trades of Electronic Mechanic/R & TV /Electrical and Fitter. post qualification industrial experience in the relevant filed will be an added advantage.**

Candidates' secured 1<sup>st</sup> Division will be given preference for all the above posts.
