NOTICE

Applications are invited for filling up the vacant posts of Junior Residents in Lok Nayak Hospital, New Delhi on regular basis (for a period of one year). The appointment shall be initially for six months extendable upto one year on the basis of satisfactory work and conduct report from the concerned HOD and written request from JR concerned and subject to vacancy position.

While the reservation for SC/ST/OBC is vertical, 4% reservation for a person with disability is horizontal. The number of vacancy may vary as per actual requirement and vacancy available.

ELIGIBILITY CRITERIA FOR THE POST OF JUNIOR RESIDENT (MBBS):-

- Qualifications:- MBBS degree from recognized University/Institute, candidate must have not completed one year Junior Residency from any Govt. Hospital.
- II. Age Limit:- As on 31.08.2018 shall be 30 years for General candidates, 35 years in case of SC/ST and 33 years in case of OBC candidates. However, if the no. of candidates eligible as per this criteria are not sufficient, the relaxation as per circular no. F.No.121/26/2010/H&FW/OSHFW/1996-2045 dated 10.06.2011 of GNCT of Delhi shall be allowed and accordingly the age limit shall be 40 years, irrespective of category. The list of these candidates under the relaxed condition will only be considered, if the candidates under the normal age as given in the beginning of para. are not sufficient.

The General Candidates who are born before 31.08.1988, SC/ST who are born before 31.08.1983 and OBC category candidates who are born before 31.08.1985 are not eligible in normal circumstances, however under the relaxed conditions, even those born prior to above dates shall be eligible however, born earlier than 31.08.1978 shall not be eligible. In respect of OBC candidates only those candidates who have OBC certificate issued by GNCT of Delhi will be eligible.

III. Pay Scale:- Pay Matrix of Level no.10 as per 7th CPC, Basic pay Rs.56100/- and other admissible allowances per month.

- IV. Only those candidates who have completed their internship after 01.01.2013 and before 31.08.2018 are eligible.
- V. The candidate must bring the original certificates i.e. MBBS/MD/MS degree, internship completion certificate, DOB certificate (Matriculation), DMC registration and experience certificate, if any, for verification at the time of interview. Those who do not have valid DMC registration certificate need not apply.
- VI. Appointment will be subject to verification of certificates of educational qualification/age/DMC registration and internship completion certificate etc.
- VII. Junior Residents who have completed one year of Junior Residency shall also be allowed to appear in the interview and will be offered residency only if fresh candidates for the post of Junior Residents are not available. There would be no extension for any Junior Resident beyond one year of appointment under relaxed provisions (vide Circular No.F.No.121/26/2010/H&FW/1996-2045 dated 10.06.2011).
- VIII. All those candidates working on adhoc basis should also apply and appear in the interview, in case of non-selection and joining of a fresh regular candidate their term of adhoc JR shall be terminated without any notice.
 - IX. No TA/DA shall be paid to all those who are appearing in the interview.
 - X. Interested candidates may apply in the prescribed format which is attached with this notice, Last date of applying is 29 Sur 18 upto 12.00 Noon.
 - XI. Fee Payable for the post of JR:- Rs. 300/- for General and OBC candidates in the form of Demand Draft preferably from State Bank of India issued in favour of "MD Lok Nayak Hospital, New Delhi" payable at New Delhi (Non refundable). SC/ST/PWD candidates are exempted from payment of fees.
- XII. Self attested copy of Date of Birth Certificate, DMC registration certificate and internship completion certificate should be enclosed along with the application.
- XIII. The candidates must bring the original i.e. certificates- MBBS degree, internship completion certificate, DOB certificate (Matriculation), DMC registration and experience certificate, if any, for verification at the time of interview.
- XIV. Application in the prescribed format along with self attested copies of date of Birth certificate, educational qualification, DMC registration certificate and experience certificate may reach in the office of the Additional Medical Superintendent (Admin.), Room no. 005, Administrative Block, Lok Nayak Hospital New Delhi-02 by above mentioned date and time.
- XV. Applications received after due date and time shall not be entertained.
- XVI. Selected candidates shall be allowed to join immediately or maximum within 07 days of issue of the offer letter failing which the offer shall stand automatically cancelled. Hence, only those candidates who can join immediately need to apply. No extension of this time period will be allowed for joining.
- XVII. The candidates will be selected on the basis of interview only.
- XVIII. The list of eligible candidates shall be uploaded on Lok Nayak Hospital Website http://delhi.gov.in/wps/wcm/connect/DoITLNJP/Injp/home.
 - XIX. They must visit website of LNH regularly for any/all update in this matter.
 - XX. All the candidates are requested to read the enclosed formats like application for allotment of ECS number and AEBAS registration and will have to submit them complete in all respects at the time of joining.

erms and conditions of contractual appointment

1. Junior Residents will be entitled for leave of 15 days (Leaves of all kind included) for every six month of service. In case the service is less than 6 months the leaves granted to them will be on a pro-data basis.

2. They will be entitled to Medical Health Facility governed by the existing Delhi Government Employees Health Scheme applicable to serving employees in

accordance with the terms and conditions contained in the Scheme circulated by letter

no. 342/52/2006-H & FW/29609-29812 dated 25/10/2007.

3. They will not be allowed LTC, Pensionary benefits, Group Insurance, Study Leave and Child Care Leave, Maternity leaves will be granted as per the provisions of the maternity benefits (Amendment) Act 2017, to the eligible female candidates.

4. The reservation in vacancies shall be followed as per decision of Govt. of NCT of

Delhi.

5. The contract may be terminated by either side with one month's notice or salary in lieu thereof. The selection is purely contractual in nature and does not confer any right for regularization or permanent absorption.

6. Private practice of any kind is not allowed.

7. No TA/DA is admissible for appearing in examination etc. Canvassing of any kind will

lead to disqualification.

8. Other conditions of service will be governed by the orders issued from time to time by GNCTD.

Jurisdiction of Dispute: In case of any legal dispute the jurisdictions of Courts will be Delhi/New Delhi only.
