**2. Emoluments: -**

Pay scale Rs. 56100-1,77,500/- plus applicable admissible allowances in pay matrix (level 10) under CCS (Revised Pay) Rules, 2016 at entry level.

**3. Eligibility:-**

- m) MBBS from a recognized University.
- n) Should be registered with Delhi Medical Council (DMC).
- o) Only those candidates who have completed / likely to complete Internship by **31.07.18** may apply.
- p) The candidates who completed Internship before **31.07.16** need not apply; as such candidates would not be eligible.
- q) Those who have already done **06** months and more Jr. Residency in Government organization is not eligible.
- r) OBC Certificate only as per **Annexure –II with required validity as mentioned at para 5 (b) below.**

**4. Age Limit:**

- a) Not exceeding 30 Years for Un-reserved 33 Years for OBC & 35 Years for SC/ST Category as on **19.09.2018**.
- b) Age Relaxation of 10 years for Persons with Disability (15 years for SC/ST and 13 years for OBC candidates).

All reservations will be considered in the above posts strictly in accordance with prescribed norms/rules.
