**Instructions**

1. The result of the Judicial Officers/Advocates who have been declared successful in UPHJS Direct Recruitment Main Written Examination, 2018 and have filed petitions in the Hon'ble Supreme Court/Hon'ble High Court shall be subject to the final outcome of the pending petitions. They are permitted to appear in the interview provisionally. Such successful Judicial Officers/advocate petitioners are required to submit a proof of petition filed by them in the Hon'ble Court and order permitting them to appear in the U.P. HJS Direct Recruitment Examination, 2018, at the time of interview along-with the current status of the writ petition.
2. The candidates who are being called for interview should bring original of all the relevant documents and should also bring one self attested copy of all the documents.
3. The successful candidates belonging to reserved category are required to submit original requisite/recent caste certificate (not more than 06 months old) in support of their claim at the time of interview otherwise their candidature shall be treated as unreserved category candidate for all purposes including eligibility.

The Duplicate Interview Call letters will be issued to the candidates from 9<sup>th</sup> March, 2019 (from 9:30 a.m.) from the Selection & Appointment Cell, 1st Floor Mediation Centre Building, High Court, Allahabad, in case they fail to received/download the same.

No T.A./D.A. shall be admissible to any candidate appearing in the interview.

Any kind of special leave shall not be permissible to the judicial officers appearing in the interview.
