The result of Fifty (50) candidates selected from Wait List of Postman/Mail Guard Examination-2014, for which online examination was held from 17.05.2017 to 21.05.2017 in Delhi Circle, is hereby declared. The list of selected candidates is annexed as Annexure-I.

2. It may be noted that as per the directions of Hon'ble CAT, P.B., New Delhi, the result is subject to the outcome of O.A. No. 1364/2017, 1911/2017 and 1782/2017. Further, the selection of the candidates is provisional and subject to satisfactory verification of all credentials like Date of Birth, Educational Qualification Certificates, Caste Certificates, Physical Disability Certificate, NOC from the employer in case of Govt. Servants, etc.


