- 4. Intermediate/+2 Examination Certificate issued by the concerned Board/Council.
- 5. Bachelor's Degree Certificate issued by the concerned University.
- 6. Required Odia Pass Certificate.
- 7. Aadhaar Card in original and it's photocopy duly attested by the candidate.
- 8. Caste Certificate by Birth in support of claim as SC/ST, wherever applicable (Caste Certificate by virtue of marriage is not accepted).

- 9. Candidates of SEBC category (other than Creamy Layer) must have to submit Caste Certificate by birth issued by the Competent Authority (issued within 3 years), wherever applicable (Caste Certificate by virtue of marriage is not accepted). OBC Certificate will not be accepted in lieu of SEBC Certificate.
- 10. Caste Certificate of SC/ST/SEBC candidates must be same & talied as per filled up in online application form.
- 11. OPSC copy of challan showing payment of examination fee (Pay in slip) for payment of fee at SBI.
- 12. A declaration regarding number of attempts exercised by the candidates in the OCS Examination in the format annexed at **Annexure-B**.

- 17. If a candidate claims to posses qualification, equivalent to the prescribed qualification, the rule/authority (with number & date) under which it is so treated, must be furnished.
- 18. Certificate of good character from Principal/Proctor/Dean or Professor in charge of Department of Teaching of the College or University/Institution in which last studied.
- 19. Two recent passport size photographs with signature on its front, which has been uploaded with online application form.
- 20. No Objection Certificate (in case of in-service candidates), wherever applicable.
