Whereas, the Higher Education Department vide communication No.HE/Coll/Apptt/A.P./2017 dated 18.10.2017, among others referred **10 posts (OM=05, RBA=02, SC=01, ST=01 & ALC=01)** of Assistant Professor, **Anthropology** in Higher Education Department to the J&K Public Service Commission for being filled up through direct recruitment from amongst the eligible/suitable candidates; and

Whereas, the J&K Public Service Commission, vide Notification **No.10-PSC (DR-P) of 2017 dated 27.10.2017** invited online applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification for the post of Assistant Professor **Anthropology** in Higher Education Department and in response to the above said Notification, the Commission received **11** applications in the said discipline; and

Whereas, the verification/ scrutiny of the documents was conducted by the Screening Committee constituted for the purpose and the documents of some candidates were found deficient and accordingly the deficiency notice was issued vide Notice dated 27.12.2018; and

Whereas, the deficient documents were received from the candidates in response to notice dated 27.12.2018 and the said documents were again verified/scrutinized by the Screening Committee; and

Whereas, the application forms received were lesser in number and some candidates were found ineligible as such no shortlisting of the candidates was required.

Now, therefore, the following candidates are hereby called for interview for the post of Assistant Professor, Anthropology in Higher Education Department, the interviews of which shall be held on 28.01.2019 at J&K, Public Service Commission Office Complex, Resham Ghar Colony, Bakshi Nagar, Jammu.
