Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken after 31.12.2010 and also bear the name of candidate and the date of photo taken. The uploaded photo will be having a validity of ten years from the date of photograph taken.

1 Name of Department : Kerala Public Service Commission

2 Name of post : Programmer (Special Recruitment from SC/ST)

3 Scale of pay : 39,500-83,000

4 No. of Vacancy :01(One)

Note:- The above Vacancy is now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years, provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Caste/Scheduled Tribe during the pendency of the list. Candidates against vacancies exclusively reported for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list that fresh notification for Scheduled Tribes for vacancies reserved exclusively for them will be issued.

5 Method of Appointment : Direct Recruitment (Special Recruitment from Scheduled Castes/Scheduled Tribes).

Note:- Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6 Age: : 20-41

(Only Candidates born between 02.01.1977 and

01.01.1998 (both dates included) are eligible to apply for this post.)

No other age relaxation will be allowed.

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 Qualifications:

MCA or B-Tech(Electrical and Electronics/Electronics/Computer Science)

OR

B.Tech(any discipline) with specialisation in Computer, ie.RGDCA or Equivalent

OR

B.Tech(any discipline) with minimum one year experience in Data Processing/Software Development

MSC with specialisation in Electronics/Physics/ComputerScience/

Mathematics/Statistics with minimum one year experience in Data Processing/software Development

Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. Those who have Aadhar Card should add Aadhar Card as ID Proof in their profile
