1.	Whether one candidate can apply for more than one post?	Yes. However, separate online application is to be filled for each post candidate intends to apply for.
2.	Whether CTC criteria can be relaxed?	CTC criteria has been computed based on Basic Pay and other allowances such as DA, HRA, TA, NPS Contribution, LTC, etc. attached to the feeder cadre post. This cannot be relaxed.
3.	Whether the prescribed eligibility conditions like educational qualifications, age, experience, etc. can be relaxed?	The eligibility conditions, like educational qualifications, experience etc. for various posts, have been determined keeping in view the requirement of the job. Hence, the recruitment to the various posts will be done strictly in accordance with the provisions laid down in the Recruitment Regulations.
4.	What will be the pattern of written examination?	The Computer Based Test (CBT) shall be in form of multiple choice objective questions and will be followed by written test which shall be paper based subjective written examination with a combination of long and short answer questions.
5.	Whether provision for age relaxation is available for Central Government, State Government and other Govt. Bodies employees?	The age relaxation is available to only those categories as mentioned in the advertisement.
6.	What is the schedule for examination?	The schedule for examination will be provided on FSSAI website in due course of time.

Facing difficulty in filling the Master's degree details in Educational Qualification column for the posts of Technical Officer and Assistant Director (Technical)	Candidates are advised to go through the Educational Qualification details mentioned in the advertisement where three alternative sets of qualifications have been mentioned. Fulfilling anyone of these three alternative sets makes candidates eligible to apply for these posts. Candidates having only PG Diploma of one year duration in the mentioned subjects have to select 'Yes' and the remaining candidates have to select 'No'. Candidates having Master's degree in relevant subjects are advised to submit their application in following manner: The candidate may select Bachelor's Degree and then others and thereafter fill the details of Under Graduate Course. Thereafter he/she have to select 'No' so as to fill the details of Master's Degree.
9.	Whether final year students can apply?	Only those candidates who are meeting the requirement of educational qualification as on the closing date of application i.e 25.04.2019 are eligible to apply.
10.	What are the probable places of postings?	The selected candidates can be posted in any of the offices of FSSAI presently located at Delhi (NCR), Mumbai, Chennai, Kolkata, Cochin, Tuticorin and such other offices as may be opened by FSSAI in future.
