Note: Merit List is prepared on the basis of aggregate of percentage of total mark secured in the qualifying examination (i.e. Kannada and English Type writing Senior) plus skill test mark secured for both Kannada and English Typing test conducted as per Karnataka Sub- Ordinate Courts (Ministerial and other posts) (Recruitment) (Amendment) Rules, 2007 and as per Govt. Order ಸಿ ಅಸು ಇ 08 ಸಹಿಮ 95, ಬೆಂಗಳೂರು dated 20.06.1995 in Annexure-2. Accordingly the candidates who got highest marks come under GM Category even though they applied in other categories.

1. Candidates at Sl.No.1 and 2 though had filed their applications claiming reservation under Schedule Caste, they having secured highest percentage, have been considered in General Merit.
2. Candidate at Sl.No.3 and 4 in the similar way though claimed reservation in category II A and SC (Rural) having secured highest percentage have been considered and selected in GM (Rural) category.
3. Candidate at Sl.No.5 though claimed reservation in the Schedule Caste, has been considered under General Merit (O).
4. Candidate selected at Sl.No.7 though claimed reservation under category II A, but selected under GM (Ex. Service Man), as no candidate available in that category.

The candidature of Sl.No.11, 14, 15, 18 and 20 have been considered for selection as per the Government Order ಸಿ ಅಸು ಇ 235 ಸೆನೆನಿ 2012, ಬೆಂಗಳೂರು dated 22.11.2016.

5. The candidate selected at Sl.No.11 as against the post reserved for General Merit (PHC) not being available in that category, next best candidate having secured higher percentage has been considered and selected.
6. The candidate selected at Sl.No.14 as against the post reserved for SC (PHC) not being available in that category, next best candidate having secured higher percentage in that category has been considered and selected.
7. The candidate selected at Sl.No.15 as against the post reserved for III A (PHC) not being available in that category, next best candidate having secured higher percentage in that category has been considered and selected.
8. The candidate selected at Sl.No.18 as against the post reserved for ST (PHC) not being available in that category, next best candidate having secured higher percentage in that category has been considered and selected.
9. The candidate selected at Sl.No.20 as against the post reserved for II B (PHC) not being available in that category, next best candidate having secured higher percentage in that category has been considered and selected.

Appointment of candidates under Reserved categories and age relaxation claimed under different categories is subject to obtaining Caste Validity Certificate (Sindutva Pramana Patra)/Income Certificate from the concerned authorities.
