The following posts are to be filled purely on contract and temporary basis from willing eligible candidates to work in Jharkhand for the ICMR funded ad-project titled "RATIONS study: A cluster randomized trial of nutritional support (food rations) to reduce TB incidence in household contacts of patients with smear positive pulmonary tuberculosis in communities with a high prevalence of under-nutrition (total duration: 3 years) implemented by this institute. This project is a joint collaborative venture of NIRT, Chennai as well as Center for Nutrition Studies, YENEPOYA (Deemed to be University), Mangalore.

Place of posting	Ranchi, Seraikela-Kharsawan, Paschimi and Purbi Singhbhum districts.
Number of posts	56 posts (14 posts for each district) UR- 27, OBC- 13, SC- 07, ST-08, EWS-01
Essential qualification	12 th class pass with science subjects with at least 2 years of experience relevant to this project. Relaxation of essential qualification to 12 th Class pass with other subjects will be considered for those with relevant field experience. Fresh 12 th Class pass-outs or those with experience not relevant to this project need not apply.
Desirable qualifications	Previous experience in field based studies or programmes, especially those related
skills and other requirements	to TB or nutrition in Jharkhand and in the district concerned, will be considered desirable. Skills in nutritional assessment, entering data and good communication skills and community interactions would be highly desirable. Candidates should have a valid driving license and own a 2-wheeler vehicle to enable their travel. Proof of domicile in the district of work would be preferred.
Age limit	Not exceeding 30years. Age limit relaxation may be considered for SC/ST/OBC candidates or those with field level experience. Candidates under EWS will have to submit a certificate in the attached format.
Emoluments	Consolidated salary Rs.18,000/- p m
Nature of Duties	Will be responsible for all field related activities that include interviewing of patients with tuberculosis, the household contacts & facilitating screening examination of the family, and their follow up. Will have to ensure timely delivery of food rations to the households. Will have to enter data on a hand-held device. Will have to take height, weight measurements of children, adults, and participate in diet surveys
Duration	Initially for a period of one year. Selected candidates should be prepared to join by 20 th of July.

- 5. All posts are contractual for the duration offered on a short-term engagement on a consolidated salary as detailed against each posts. The appointment is likely to be continued after every specific period of time subject to satisfactory performance of respective P.I of the project and subject to approval of Director to a maximum upto the end of the project.
- 6. Since the appointment of all the posts are under project funded by different agencies, the incumbents selected will have no claim for regular appointments under NIRT/ICMR or continuation of his/her services in the same project of any other project.
- 7. TA/DA will not be paid for attending the written test/interview.
- 8. The institute reserves the right to fill up or not to fill the advertised posts even after conducting walk-in-interview/test.
- 9. The Director/Selection Committee has the right to accept/reject any application without assigning any reason thereof and no recommendation in this matter will be entertained.
