Reference advertisement No.PGI/RC/094/2018/6379 dated 11.12.2018 issued for recruitment of various group 'B' and group 'C' posts followed by corrigendum dated 20.02.2019. It is for information of all candidates that the result of written examination for the posts of **Perfusionist and Stenographer** which was held on 03.06.2019 have been declared and uploaded on the website of the Institute. The candidates can check their result in the link provided on the website of PGIMER i.e. [www.pgimer.edu.in](http://www.pgimer.edu.in) by filling his/her roll number and date of birth in the column provided in the link. Candidates should note that the result is merely a list of those candidates who have qualified the written examination as per the criteria of minimum marks prescribed in the advertisement notice. Therefore, inclusion of a name in the list should not be taken as a selection for the above posts. Selection to the posts will be done amongst eligible candidates (as per recruitment rules) on the basis of the marks obtained in the written examination. The Institute has not so far, verified the details like age, qualification, experience etc. as required under recruitment rules for the posts.

Therefore, all the shortlisted/qualified candidates are informed that they have to apply afresh in the prescribed application form which can be downloaded from PGI website [www.pgimer.edu.in](http://www.pgimer.edu.in) and send the same alongwith all certificates duly attested by the Gazetted Officer so as to check their eligibility for the above said posts.

**All columns of the application form are to be filled in and no column should be left blank. No further addition or deletion in the application form will be allowed. Entries filled in the application form, duly supported by the relevant certificates will only be considered. The applications complete in all respect and accompanied with all the certificates must reach the Administrative Officer, Recruitment Cell, PGIMER, Sector 12, Chandigarh – 160012 through speed post/registered post/by hand on or before 28.06.2019 upto 04:00 PM. No application received after this date i.e. **28.06.2019** will be entertained and candidature of such applicants will be treated as cancelled. The candidates are, therefore, advised to apply as soon as possible so that their applications must reach the Recruitment Cell of PGIMER, Chandigarh well before the last date. The Institute would not be responsible for postal delay due to any reason. The envelop carrying the application alongwith testimonials must be clearly subscribed in capital letters the name of the post applied for i.e. Perfusionist and Stenographer.**

On receipt of applications of the shortlisted candidates, the scrutiny of these applications will be done for verifying the eligibility of the candidates for the posts by the Scrutiny Committee of the Institute. The scrutiny/eligibility will be determined as per the Recruitment Rules/guidelines/detailed information as notified in the advertisement and the documents submitted by the candidates.
