**RESULT**

On the basis of Examination/ Test for the posts of HCS (Ex.Br.) through Register A-II of members of group 'C' Service for the year - 2019 conducted by the Haryana Public Service Commission on 31.07.2019, the candidates, three times the number of vacancies along with bracketed candidates, if any, bearing the following Roll Nos. have been declared qualified for Viva-Voce provisionally, subject to the fulfillment of all eligibility conditions.
