Essential qualifications required for appointment to the post of Joint Commissioner is as under-

- Holding Analogous post on regular basis. OR
- With 05 year service in the scale of Rs. 12000 16500 (GP 7600 as per 6th CPC, Level 12 of the pay matrix of 7th CPC.)
- 3. With 8 years of combined regular service in the scale of Rs.10,000-15,200 (GP Rs.6600 as per 6th CPC and Level-11 of the pay matrix of 7th CPC) and Rs.12,000-16,500 (GP Rs.7600 as per 6th CPC and Level-12 of the pay matrix of 7th CPC).
- 4. Possessing experience of handling administrative /academics matters in a responsible capacity.

Terms and Conditions

- 1. The period of deputation would be initially for a period of one year, which may be extended further at the discretion of the Competent Authority
- The officers selected will have the option to draw either his/her grade pay plus Deputation (Duty) Allowance or his pay fixed in the scale of post as per existing Govt. of India instructions.
- 3. In Navodaya Vidyalaya Samiti, being an autonomous body, the employees are neither eligible for allotment nor retention of general pool accommodation.
