**2. Eligibility:**

- MBBS with PG degree/diploma/DNB in concerned specialty from a recognized university (as well as the specialty recognized/permited by MCI).
- Should be registered with Delhi Medical Council (DMC) for MBBS.
- DMC Registration for PG/Acknowledgment for Registration of DMC for PG.



- h) The candidate should complete the tenure of PG Degree/Diploma on or before **31.12.2019.**
3. **Pay Scale:**  
Revised Pay Matrix Level 11 (Rs. 67700-208700/-) under CCS (Revised Pay) Rules, 2016 at entry level. Allowances as admissible will be paid.
4. **Age Limit:**  
a) Not exceeding 40 years (relaxable by 5 years for SC/ST, 3 years for OBC) as on **31.12.2019.**  
b) Age Relaxation of 10 years for Persons with Disability (PWD). 15 years for SC/ST and 13 years for OBC candidates of PWD.
5. **Reservation:**  
All reservations will be considered in the above posts strictly in accordance with prescribed norms/rules.  
a) SC/ST candidates to submit copy of community/caste certificate.  
b) OBC candidates should submit OBC Certificate as per given format of Govt. of India (Annexure –II) having date of issue on or after 31.12.2016 vide OM No. 36036/2/2013-Estt.(Res-I) dated 31.03.2016 of DOPT, Ministry of Personal & Public Grievance & Pensions, New Delhi.  
c) EWS candidates to submit copy of Income & Asset Certificate as per given **annexure –III having date of issue on or after 31.01.2019 vide OM No. 36039/1/2019-Estt(Res) dated 31.01.2019 of DOPT, Ministry of Personal & Public Grievance & Pensions, New Delhi**  
d) Persons with disability (PWD) to produce/submit a certificate issued by a competent medical authority.  
e) 14 posts are reserved for Persons with Locomotor Disability (PWD- Orthopedically) Candidates includes anticipated vacancies.  
f) 07 posts are reserved for Economically Weaker Sections (EWS).
6. **Terms & Conditions:**  
b) Application should be **accompanied by a Demand Draft of Rs. 800/- for Un-reserved & OBC Candidates [non refundable], issued after the date of advertisement,** drawn on a scheduled bank in India, in favor of **Pay & Accounts Officer, Dr. R.M.L. Hospital, New Delhi payable at New Delhi. SC/ST/EWS candidates and Persons with Disability (PWD) candidates are exempted.**  
c) It must be ensured by the candidates that **Application in prescribed form (Annexure-I) along with latest passport size photograph along Self attested copies of all documents should be delivered/received, either through post or by hand, at the Central Diary and Dispatch Section, Near Gate No. 1, Dr. Ram Manohar Lohia Hospital, New Delhi latest by 31.12.2019.**  
d) **The Hospital will not be responsible for any Postal delay.**  
e) Incomplete application in any respect will not be considered. All previous applications received in this hospital will be treated as cancelled and only application in response to this Advertisement in the Prescribed form (Annexure-I) will be considered.  
f) The list of rejected candidates, after screening of applications, will be displayed on the Hospital website ([www.rmlh.nic.in](http://www.rmlh.nic.in))/notice board of the HA.II Section latest by **15.01.2020.** All representations regarding rejection should be received in the Section latest by **22.01.2020 till 4:00 P.M. No representation will be entertained after the date mentioned above.**  
g) Crucial date of determination of eligibility with regard to age will be **31.12.2019.**  
h) The selection will be based on written examination and Interview.  
i) The schedule of written examination will be mentioned on the Admit Card.  
j) **The Admit Card will be uploaded on hospital website only ([www.rmlh.nic.in](http://www.rmlh.nic.in)).**  
k) **OBC Candidates should submit the OBC certificate as per Annexure-II with required validity as mentioned at para 5 (b) above.**



- l) The tenure of Senior Resident is for 03 (three) years including any service rendered earlier as Senior Resident on ad hoc/regular basis in any govt. institution. Under no circumstances, the total period of Senior Residency shall exceed three years, at the time of Joining ABVIMS & Dr. Ram Manohar Lohia Hospital. The appointment will be initially for the period of one year, which could be extended for a period of three years on annual basis, subject to the satisfactory work and conduct report.
- m) Delhi Medical Council registration is mandatory at the time of submission of application.
- n) Other service conditions will be applicable as per service condition prescribed from time to time by the Government of India.
- o) The candidate who is already in Govt. Service should submit No Objection Certificate from the present employer.
- p) Inter hospital/Inter Institutional transfer shall not be permitted.

  12. NOC from present employer (if employed).
- r) The candidates must submit the application in the prescribed form (Annexure-I) and paste recent passport size photograph on it. All the documents must be self-attested including his/her photograph on the application form.
- s) The candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement.
- t) The competent authority reserves the right to verify the authenticity of the Certificates submitted. If found incorrect, the candidature will be cancelled without any further notice
- u) **In case the number of eligible candidates who qualifies in the written examination is high, the hospital may shortlist the number of candidates to be called for interview.**
- v) Jurisdiction of Dispute: In case of any legal dispute the jurisdiction of court will be Delhi/New Delhi only.
- w) **Cut-off for written examination will be 50 % for UR/EWS, 45 % for OBC, 40 % for SC/ST and additional 5 % relaxation will be given to PWD candidates in their respective category.**
